HUEY LONG SUED FOR \$250,000 BY MRS. PLEASANT

Senator Defamed Her and Caused Illegal Arrest, States Petition

pleas in that office, asking them to smell my breath to show that Senator Long was prevaricating as usual.

Senator Long, on the day after the statement was made by Mrs. Pleasant, said he knew nothing of the charges, stating that he had only gone up to the office of the supervisor of public accounts to keep them from putting Mrs. Pleasant in jail.

Pleasant Signs Petition

The petition filed in the East Baton Rouge district court Tuesday was signed by former Governor Pleasant, E. Wyles Brown and Howard B. Warren of Shreveport and Paul G. Borron of Baton Rouge as attorneys.

This is the second court action brought against Huey P. Long personally in the East Baton Rouge courts. The other action was brought in 1922 by District Attorney John Fred Odum, charging libel as the result of the issuance of circulars attacking John M. Parker, who then governor. Supreme Justice H. F. Brunot, who was then district judge at Baton Rouge, found him guilty on two counts and gave him a suspended sentence of 30 days on one count and he paid a fine of \$1,000 on the other. Judge Brunot explained that he was making the sentence light because of Mr. Long's impulsive nature and expressed the belief that "the recollection of this trial will deter you in the future from exceeding the bounds of careful and legitimate criticism of your fellow man."

The full text of the petition filed Tuesday in the East Baton Rouge court follows:

Text of Petition

"The petition of Anne Ector Pleasant, wife of Ruffin G. Pleasant, both residents of Caddo parish, state of Louisiana, with respect represents:

"That Huey P. Long, Jr., who resides in the city of New Orleans, parish of Orleans, state of Louisiana, is justly and truly indebted unto your petitioner in the full sum of two hundred and fifty thousand (\$250,000) dollars for this, to-wit:

"That at or about the hour of 2:30 p. m. on Wednesday, the 15th day of June, 1932, the said Huey P. Long, Jr., without any just cause or provocation, did, in the office suite of Miss Alice Lee Grosjean, supervisor of public accounts in the state of Louisiana in the state house, in the city of Baton Rouge, East Baton Rouge parish, Louisiana, and in the presence and hearing of a large number of persons, call your petitioner a 'drunken, cursing woman,' which expression was untrue and libelous and uttered without probable cause; that he then ordered one R. L. Whitman to seize her and put her out of the state house; that, accordingly and in response to the said command, she was seized, and for an appreciable time, held in custody against her will by the said Whitman, in the command of the said Huey P. Long, Jr., who was not a peace officer and had no authority to cause arrests to be made in the said state; that the arrest was a false and illegal arrest and detention, and your petitioner, as your petitioner was not disturbing the peace, nor committing any offense whatever against the laws of the state of Louisiana or against any other governmental authority, but was merely sitting in the said office quietly waiting for an opportunity to make a respectful inquiry of the said supervisor of public accounts relative to the practice of nepotism and the questionable use and disposition of the taxpayers' money in certain state offices, departments and institutions.

Says Assertion Libelous

"That, in a purported interview given at the city of Baton Rouge by one J. D. Trahan, at the request, instigation and suggestion, and in the presence of the said Huey P. Long, Jr., for publication in the New Orleans Item, a newspaper domiciled in the city of New Orleans, and with a general circulation throughout the state, including the parish of East Baton Rouge, and published in said newspaper on or about Thursday, June 16, 1932, the said J. D. Trahan is quoted as saying that your petitioner was suspected of carrying a pistol in her purse on the aforesaid occasion in the said supervisor of public accounts office; that all of the said assertions were fictitious, false, malicious, infamous, 'amaging, libelous and injurious to the petitioner's good name and reputation, and were made with the intention of injuring her said reputation with her friends, neighbors and acquaintances, and with the public generally, that said issue of said newspaper was circulated at the time of its issuance in East Baton Rouge parish, and other portions of the state.

"That all of the said statements so uttered or approved by the said Huey P. Long, Jr., were entirely false, scandalous, malicious, and defamatory of your petitioner's good name, credit, and reputation, and the said arrest was against her will, and was scandalous, illegal, unjust, malicious, and injurious to her good name, credit and reputation, all of which was said and done with the intention of injuring your petitioner in the estimation of her friends, neighbors, acquaintances, and the

Charges in Suit Denied by Long

Washington, May 30.—Senator Huey P. Long today denied Mrs. Anne Ector Pleasant had been ejected from the state capitol by him.

Informed of the \$250,000 suit, Long said:

"That means that up to date I have been sued for \$1,250,000. There's such a thing as a man living on the interest of what he owes."

"Wherefore, premises considered, your petitioner prays that the said Huey P. Long, Jr., be cited to appear and to answer this petition, and that after due proceedings had, he be condemned by judgment of this honorable court to pay unto your petitioner the aforesaid sum of \$250,000 damages, with interest from judicial demand, and all costs of this suit."

Asks \$250,000

"That your petitioner is of legal age, has lived in the state of Louisiana for more than 30 years, and is, and always has been, a law-abiding citizen; that she has never been a drinking or cursing woman, nor guilty of any offense of any kind whatsoever against any law in her whole lifetime, and especially has she been guiltless of any offense that merited the ignominy of arrest. Nor has she ever owned or carried a pistol and does not know how to use or operate one; that she has reported herself a woman of respectability, character and honor, and in keeping with the high positions to which the people of the state of Louisiana have kindly and graciously elevated her husband, and therefore in a measure, herself; that she has always enjoyed the esteem and confidence of her friends and acquaintances and of a large number of other good people in her neighborhood, the state of Louisiana, and other states; and that by reason of said slanderous and defamatory words and accusations uttered by the said Huey P. Long, Jr., and the said false arrest and detention ordered and therefore participated in by him, and because of the consequent hurt to your petitioner's feelings, and her humiliation and mortification, she has suffered damages in her good name, reputation, credit and feelings in the full sum of \$250,000.

"Wherefore, premises considered, your petitioner prays that the said Huey P. Long, Jr., be cited to appear and to answer this petition, and that after due proceedings had, he be condemned by judgment of this honorable court to pay unto your petitioner the aforesaid sum of \$250,000 damages, with interest from judicial demand, and all costs of this suit."

PROFITS SHOW GAINS FOR UNITED FRUIT

Business Improvement in April Doubles 1932 Figure

Boston, Mass., May 30.—It is indicated that the United Fruit Company has been sharing fully in the improvement in business that followed the termination of the bank holiday in March. Largely as a result of the rigid control of costs and in spite of lower selling prices for bananas as compared with a year ago, profits for April were about 80 per cent of those of the entire first quarter—\$1,033,000—and were by the same token in excess of the \$800,000 before reported for the second quarter of 1932. April net was actually double that of April, 1932.

Seasonally, May is always ahead of April and this year, in common with most of the fruit production and distribution, United Fruit has experienced a better than seasonal gain in sales. As a consequence, earnings should run ahead of April. Federal Court Decree Follows Foreclosure on Mortgage

(By The Associated Press)

Jackson, Miss., May 30.—Property of the New Orleans Great Northern Railroad Company will be sold at public auction here June 29, under a federal court foreclosure decree, it was announced today by James N. Ogden, special master. The decree is a foreclosure of the mortgage of the Irving Trust Company as trustee, Ogden said.

The road runs from New Orleans to Jackson and operates a 31-mile branch line from Slidell to Covington, La., another branch 41 miles long from Rio, La., to Tylertown, Miss., and a third small branch from Foxworth to Marion, Miss., 2.48 miles long.

The property is split into two parcels, and the decree authorizes the special master to offer the parcels separately and then together, accepting the highest bid, subject to court approval.

The first parcel includes the main and branch lines, tracks, switches, locomotives, railway cars, including six Brill gas-electric and gas cars, real estate including depots but not including that listed in parcel 2, which includes a strip of land three miles long in Hinds county and several smaller parcels of land and property in Washington and St. Tammany parishes, Louisiana.
